



SIR DYNAMITE was in no rush for the first mile, then stalked the leader until the second last, dueled briefly and then drew clear and was ridden out to the wire. DUGAN was well off the pace, got into contention on the backside for the final time was right there jumping the second last but could not keep up with the winner. MORE TEA VICAR assumed command from the beginning, was headed at the second last jump and fell back from there. COMPLETE ZEN was in contention and then started falling back after the second last jump. CALL ME SONNY trailed the field and was no factor here. SOUTHERN ADMIRAL was through after a mile, fell back and was pulled up before the final hurdle. SULWAAN (IRE) had a rough trip throughout and fell at the seventh jump.
