BALDWIN COUNTY dueled from the inside for the first quarter, inched ahead down the back stretch, held a safe advantage with a game effort to prevail. STONE CANYON was unhurried early dropping in to save ground along the rail, placed a bid angling out three wide in the stretch and was gaining late. NICK MISSED was five wide into the first turn then dropped in to save ground down the back stretch, vied into the stretch angling out three wide and lacked a gain late. BUTTE CITY was unhurried early and lacked a late response. BAYOU THE MOON went six wide into the first turn, angled in to save ground and failed to menace. HIS WAY dueled the first quarter from the outside, then stalked the leader to the quarter pole and gave way in the stretch. SOCKO raced wide through out and failed to threaten.
