EVANSVILLE VAN trekked the two path, attended pace and led between calls, came again to win the nod at wire. WED TOO QUICK saved ground and locked into a stretch duel with eventual winner but was outnodded at wire. WOOD BE LAWYER trailed the field early and closed with rush to earn show while gaining on leader at finish. BLASTITARY lacked a closing bid to end a three path trip. ONE TOUGH HOMBRE angled out to three wide but lacked any offering to give in final furlong. TOCCING MAN lost ground to front runners with wide trip. ROBYNS RETURN failed to menace from a back rated pose. GRAY FLYER saved ground and was no threat.
