Footnotes

RIVER JONES jostled about at the break, was rated off the early speed, three to five wide taking the bend, all out in the lane, gained a narrow advantage with a sixteenth left and held on. CRACKLING BULL rated between horses, progressed in close quarters two wide on the turn, was checked behind the fading SIMPLE DEAL leaving the turn, altered in, was behind traffic just off the inside upper stretch, altered in again, swiped the rail with a furlong to go, was steadied, regained his stride, closed well but just missed in a game effort. FLAPS in midpack between horses, angled in entering the turn, gained the advantage leaving the bend, battled from path two in the lane, was brushed just inside the last eighth, tried hard but did not have enough left the final sixteenth. FEELIN LIKE DANCIN chased from inside, reached contention on the turn, lost his path upper stretch, was altered out at the eighth marker, was blocked again, altered inside with a sixteenth left and hung. SUAVEY raced closest to the early speed, vied for the lead three wide leaving the turn, fought through the lane, brushed with FLAPS just inside the last furlong and began to wear down. SUNKA CAT soon trailed from inside, swung out six wide for the stretch run, had a striking position with a furlong to go but leveled off instead. ELEGANT ATTITUDE broke inward, jostled briefly with SIMPLE DEAL, ran in midpack from outside, went for the lead four wide on the bend but could not sustain his bid through the lane. CORKED was soon widest, lost the most ground taking the turn, reached contention from the middle of the track upper stretch but flattened late. RAZZLEBABY chased from between horses but faded four wide leaving the turn. SIMPLE DEAL roughed between rivals at the start, quickly recovered, sprinted clear, was overtaken from both sides on the turn, checked in close quarters leaving the bend and continued to give way. CALL THE LAW backed out of the gate just before it opened and did not race. After a stewards' review of the start, CALL THE LAW was declared a non-starter and all wagers on him were refunded.
