Footnotes

CARDENALA vied for the lead inside from the beginning, was steadied when her path narrowed early in the bend, continued along the rail, moved ahead upper stretch and held on under steady urging. PACHE LADY contested the pace from outside, failed to keep up while three then four wide taking the turn, was all out deep stretch, closed well but a bit short. SCATTI PATTI dueled for the lead between CARDENALA and PACHE LADY, moved ahead on the turn, fanned out some for the stretch run, had every chance, lacked the extra needed but was clearly best of the rest. POP MY CORK breaking inward some, was steadied briefly, advanced between horses, was just off the inside entering the turn, gradually angled out taking the bend, came seven wide into the lane, was altered in when her path was taken nearing the eighth pole then gradually made up ground without threatening. DUSTY DIAMONDS an early factor between rivals, lost position while just off the inside taking the bend, altered out for a clear path at the top of the stretch, drifted out further with three-sixteenths left, held a straight path the final eighth but slowly yielded. RIO DE LANEY RAE very fractious in the gate, was taken out of the gate, reloaded once settled, void of speed while toward the outside, three wide on the turn, fanned out to path six into the lane, altered in for room soon after and also lacked a late bid. PIMA COUNTY progressed from inside to have a striking position with a quarter mile left but wore down for the drive. CMON PATSY trailed from inside, floated out some on the turn, came into the stretch from path four and proved unresponsive. EAGLE'S PULPIT void of speed though hustled along from outside, stayed wide throughout and showed little.
