STORMIN WILDCAT was settled off the pace while angling to the inside early, shifted out four wide leaving the turn, then produced a sustained response to collar AMBER'S SHORTY in the final strides to prevail under firm right handed encouragement. The latter stalked just outside the pacesetter under some reserve racing to the turn, pressed the leader into upper stretch, took over from that foe between calls late and just failed to contain the winner. SHIP FROM ABROAD broke in, bumped AWESOME BREW, was collected off that foe and hustled to the lead, set the pace into upper stretch, battled with a rival through midstretch but yielded to the top pair late. BEWARE THE TIGER angled to the inside in early stages, was held up just off the pacesetter racing in close quarters entering the bend, altered course three deep leaving the furlong marker but was outkicked by the top trio. RULER OF THE COURT tracked just off the pacesetter three deep racing to the bend but steadily retreated nearing upper stretch. AWESOME BREW, bumped at the start, was righted to track the leaders off the inside but never gained contention. BIG BRUIN shifted off the inside in the opening quarter, was steadied in traffic after the opening quarter and soon dropped out.
