Footnotes

RAILLERY, never far back, was rated while stalking just off the pacesetter a bit off the inside in the opening stages, steadily drew on terms with the leader nearing upper stretch and was roused clear leaving the furlong marker to prove clearly best. KITTEN'S KITTEN, caught five, then four deep in the opening furlong while being settled into stride, continued unhurried outside foes to the far turn, commenced a steady advance four deep on the second bend, couldn't gain terms with the winner but prevailed for second nearing the wire. APPEALING DIVA, held up four wide racing just off the second flight racing to the backstretch, continued unhurried well off the inside to the second bend, was fanned six wide racing into stretch commencing her bid and finished willingly to gain a share. NORTHERN SWALLOW angled in to track off the second flight in the opening stages, came through close quarters leaving the far turn to split foes entering upper stretch to challenge but was outfinished for a placing. VIA DI ROMA settled along the rail in the opening half, awaited an opening leaving the far turn, angled out five wide in upper stretch and continued with mild interest between foes. SHEZA SWEET LEMON sped to the fore along the inside racing into the first turn, dictated the pace on a clear margin under light rating to the far turn, briefly resisted the winner's challenge to midstretch but yielded late. TRIBUTE TO MOMMA, reserved along the inside in second flight racing to the far turn, steadily faded from contention nearing upper stretch. GLEASON CITY tracked the leaders three deep leading the second flight into the backstretch, continued in that path on the far turn but came up empty in upper stretch.
