Footnotes

PROCEED BEE angled inwards from the break while securing the lead, dictated the pace along the inside into the backstretch while under firm rating, continued to set the tempo on a narrow margin while shifting a bit off the inside leaving the far turn, drifted out racing through upper stretch but responded to brisk handling to gamely fend off his rivals to the end. PRINCEVILLE CONDO, shut off at the start, was caught four wide racing into the first turn while being settled into stride, gradually gathered momentum shifting outside foes on the far turn, swung six wide nearing upper stretch while producing a solid late response and just secured second on the wire while quickly closing the gap on the winner. PUBLIC SPEAKER, reserved in second flight along the inside in the opening stages, was held up out of tight quarters entering the backstretch, shifted outside the pacesetter while gaining striking distance on the far turn, angled inside that foe to challenge entering upper stretch, made steady progress to the end and was just outnodded for the place. FOREST ATTACK tracked the leaders unhurried racing three wide to the backstretch, advanced to challenge four wide between foes racing through the far turn but was outfinished. QUITE A HANDFUL shifted inwards impeding PRINCEVILLE CONDO at the start, secured a forward placing stalking just outside the pacesetter racing to the backstretch, was reserved between foes entering the far turn while working his way to the rail, made a brief bid inside foes nearing upper stretch but proved empty in the final stages. GIANT OAK was settled saving ground in the opening half, shifted out five wide entering the far turn while making some progress to contend but couldn't produce the needed final response. VOY POR UNO MAS tracked the pace between foes in the third flight early, shifted out after a half to make a brief, three wide bid entering the far turn, then was steadied between foes while quickly losing momentum on the far turn.
