Footnotes

KETTLE CORN, reserved between foes from off the second flight in the opening stages, shifted outside foes after the opening quarter, advanced to contention racing four wide on the turn, continued in that path through upper stretch while drawing on terms with the first flight and prevailed in the final stages under energetic handling. FAMILY FOUNDATION tracked just off and outside the pacesetter in the second flight early, moved to challenge three deep between foes racing into upper stretch but was just outfinished. JILLY FROM PHILLY settled in hand outside a rival in the opening stages, shifted out midway through the backstretch, made steady progress racing five wide on the turn, continued in that path through the stretch but was outkicked while finishing well enough to earn a share. SANTAMONICACANYON pulled his way clear racing off the inside in the opening half while under rating, dictated the pace racing just off the inside into the turn, resisted challenges from both sides racing into upper stretch and yielded in late stages. RULER OF THE COURT worked his way to the inside early gaining a position just off the second flight, advanced along the rail on the turn to challenge inside the pacesetter after six furlongs, dueled for command past midstretch but flattened out late. STARTINGOLD settled along the inside in the opening half, shifted out racing through the turn but never gained striking distance. TSUNAMI KING tracked off the second flight between foes in the opening half but retreated from contention early. JIMMY GOT EVEN angled inwards to track just inside the pacesetter in the opening stages but steadily faded nearing upper stretch.
