Footnotes

MOROCCAN BREW angled to the rail in the opening stages stalking just off the leaders under light reserve racing into the bend, shifted a bit off the inside while moving to split foes in upper stretch, exchanged solid contact with SLAMMIN EASY and GRACIES BRUDDER nearing the furlong marker, continued with interest while being buffeted for nearly a sixteenth of a mile, then wrested command and drew clear late under pressure. SLAMMIN EASY broke inwards making some contact with DUKE OF DEL REY, was righted to stalk just outside the pacesetter racing into the bend, moved to force the issue nearing upper stretch, leaned in approaching the furlong marker under right handed pressure bumping MOROCCAN BREW, exchanged several bumps with that foe past the furlong marker and proved no match in the final sixteenth while best of the others. DUKE OF DEL REY, bumped at the start, recovered quickly to track just off and outside the leaders as part of the second flight, then continued three deep racing into upper stretch while finishing evenly for a share. GRACIES BRUDDER was hustled up the rail soon after the break to dictate the pace on a narrow margin into the bend, duled when challenged racing into upper stretch, was bumped by MOROCCAN BREW approaching the furlong marker, continued to exchange repeated contact with that foe then was checked out of close quarters nearing the sixteenth marker while quickly giving way. PRIVATE WARRIOR was settled in last racing to the turn and never gained contention. I'M INCLUDED, urged along between foes to gain a contending position in the opening stages, continued under pressure in the second flight racing into the turn and steadily faded racing into upper stretch. CUARTO CUATES was a brief factor three wide between foes in the second flight but retreated from contention early. FOLLOWING THE RACE THE TRAINER OF GRACIES BRUDDER LODGED A CLAIM OF FOUL AGAINST THE RIDERS OF MOROCCAN BREW AND SLAMMIN EASY. THE RIDER OF GRACIES BRUDDER ALSO LODGED A CLAIM OF FOUL AGAINST THE RIDER OF MOROCCAN BREW WHILE STEWARDS CONDUCTED A CONCURRENT INQUIRY. FOLLOWING A REVIEW OF THE STRETCH RUN THE STEWARD DISQUALIFIED SLAMMIN EASY FOR INTERFERENCE, PLACING HIM FOURTH.
