Footnotes

BEWARE THE TIGER, reserved along the inside in the opening half, made steady progress inside foes entering the turn, shifted out nearing upper stretch to split foes three deep, took charge and drew clear under pressure. BIG BRUIN was settled between foes in the opening stages, advanced to contention shifting five wide racing into upper stretch, continued with a steady bid and proved best of the others. GO PATRICK GO broke outwards bumping POPLAR HOUSE, was righted to track the pace between foes in the second flight racing to the turn, shifted out nearing upper stretch to challenge four wide racing into the lane but lacked the needed late kick. PLEASANTLYSURPRISE angled to the rail tracking off the first flight, came through to bid inside the pacesetter nearing upper stretch but flattened out in late stages. TRAVELIN HOME was settled between foes in the opening stages and never gained striking distance. SANTAMONICACANYON was urged to the fore, dictated the pace on a narrow margin shifting off the inside racing to the bend, dueled outside a rival racing into upper stretch and gave way. POPLAR HOUSE, bumped, then clipped at the start, settled outside foes and never gained contention. RULEROUS was a brief factor four deep prompting the pace but gave way early. HUCKLEBERRY BOY pressed the pace between foes racing to the turn and gave way entering the bend. FOLLOWING THE RACE THE RIDER OF POPLAR HOUSE LODGED A CLAIM OF FOUL AGAINST THE RIDER OF GO PATRICK GO. THE STEWARDS REVIEWED THE INCIDENT AT THE START AND DISQUALIFIED GO PATRICK GO, PLACING HIM SEVENTH.
