FIFTEEN ROUNDS raced close up off the rail, rallied to the front in the stretch, dropped over to the rail in the stretch and prevailed. GOULDINGS GREEN lacked speed inside, rallied in the stretch, was forced to steady and alter course then could not make up ground late. THREE HOUR NAP lacked speed off the rail, rallied in the stretch, was bumped late and flattened out. SEMAPHORE MAN raced three wide near the middle of the field and weakened. WITH DISTINCTION set the pace from the inside and tired. AFTER A STEWARDS' INQUIRY AND A CLAIM OF FOUL BY THE RIDER OF GOULDINGS GREEN, FIFTEEN ROUNDS WAS DISQUALIFIED FROM FIRST AND PLACED SECOND FOR INTERFERENCE IN THE STRETCH.
