Footnotes

COUNT DE BARAN reserved along the inside while swerving a bit in the opening stages, was held up just off the leaders racing to the bend, angled three wide with a quarter mile to go and moved to wrest command in the last furlong, drawing clear under firm encouragement. SHOW YOUR FACE was settled off the inside in the opening half, shifted out four deep entering upper stretch and continued well enough to secure second. PIOUS PETE broke readily, stalked just off the leaders racing to the bend, moved to press the pacesetter on the bend to gain a brief advantage in upper stretch but had no final kick. TOQUINHO disputed the pace from the outset racing along the inside, gained brief command when inheriting the lead nearing the turn but faltered nearing midstretch. SHERIFF MAX tracked the leaders off the inside racing to the bend but couldn't produce the needed closing bid. FAST DEPOSIT raced well outside foes after his rider lost his irons at the start and soon dropped out of contention.
