ANN OF THE DANCE was reserved off the second flight near the inside in the opening stages, shifted off the rail on the bend while continuing under patient handling, steadily advanced to contention angling nearer to the inside racing into upper stretch, then split foes three deep with a determined advance to wrest command in time under firm encouragement. SPANISH AMBASSADOR was urged to the fore along the inside, dictated the pace on a clear margin into upper stretch, couldn't contain the winner but continued willingly for the place honors. BERRY KNOLL tracked off the second flight outside a rival in the opening stages, angled to the rail nearing the turn while steadily moving to contention on the bend, shifted outside the pacesetter racing into upper stretch to bid between foes but was outkicked by the top pair. BLUE FORTY tracked the pacesetter outside a rival as part of the second flight racing into the turn, shifted out four wide racing into upper stretch and lacked the needed final response. TRAC N JAM was settled last racing to the turn, then gained some position between foes in the closing stages while making no real impression. LOCK N LOLA tracked the leader inside a rival in the second flight, then steadily faded between foes leaving the turn.
