GO GO MOJO raced inside near the middle of the field and moved up in the stretch but lacked a winning bid. RUN FOR DIXIE made a bid on the turn but flattened out. BAD ATTITUDE steadied at the start, lacked speed and improved his position. BRING THE KIDS lacked speed and was not a factor. I'M A GOOD GUY raced close up off the rail and gave way. LAC LUSTY was always outrun. LORD OF THE MINT raced off the rail and gave way. MIDAS POINT was through after a half.
