UNCLE JEEP was rated just out of striking tracking the first flight inside foes a bit off the inside racing to the bend, continued with a steady advance to split foes three deep racing past midstretch and just edged his entrymate in the final strides under firm handling. ENDLESS DRIVE tracked just off the first flight outside foes in the opening stages, was rated off those foes to track outside his entrymate racing four deep on the bend, moved to challenge in that path entering upper stretch, gained the advantage late but failed to contain the winner. JOST VAN DYKE, reserved off the second flight while shifting off the inside racing into the turn, swung five wide entering upper stretch and found his best stride late to just miss. SPARE ME THE DRAMA hopped at the start, settled into stride outside foes racing to the bend, swung out five wide racing into upper stretch and made some belated progress while finishing in hand approaching the wire. RANSOM CANYON, bumped, then forced in at the break, was settled into stride and made some belated progress in the last furlong. VILLE was urged to the lead along the inside, dueled for command racing into the turn, shook clear into upper stretch but faltered leaving the furlong marker. FRANKLIN COUNTY, reserved near the inside early, never gained contention. UNO PECADOR was urged to gain terms with the first flight four deep early, pressed the issue three deep on the turn and came up empty entering upper stretch. VAN DEMON, broke inwards bumping RANSOM CANYON, was righted to briefly contest the pace three deep between foes racing to the bend but retreated early. LOLLIPOP (ARG) joined the pace between foes from the break, pressed the issue to strike the front leaving the turn but gave way nearing midstretch.
