EYE CANDY ANNIE, reserved saving ground in the opening half racing behind the second flight, steadily gained contention inside foes on the far turn, shifted out three wide in upper stretch and responded to strong handling in the closing stages to prevail on the wire. ATLANTIC TAP stalked just off the first flight along the rail racing to the backstretch, made a sharp move to contention when given her cue on the far turn, shifted just outside the pacesetter to challenge for command racing into upper stretch, gained a narrow advantage nearing midstretch and gamely held a rival to the end to finish on even terms at the wire. DELIGHTFUL DAISY was urged to the fore along the inside racing into the first turn, disputed the lead inside foes through the backstretch, edged away to clear advantage racing into the far turn, briefly resisted when challenged racing into upper stretch but yielded to the top pair late. LOOKINATMINDY, reserved between foes behind the second flight in the opening half, angled to the rail on the far turn while making steady progress, shifted out four deep in upper stretch but lacked the needed final kick. EMONA was settled outside foes racing to the backstretch and passed some tiring rivals racing into the stretch. SPRINGTIME SPELL joined the pace between foes racing into the first turn and emptied out after a half. JULIET TANGO was guided to the rail in early stages while settling in last and never gained contention. SONGS AND SONNETS hopped a bit at the start, gained a position outside a rival in the second flight racing to the backstretch, was caught four wide racing into the far turn and steadily faded from contention. HOIST THE COLORS, forwardly placed three deep in the opening stages, moved to press the issue in that path entering the backstretch, forced the leader's pace racing

to the far turn and gave way.
