Footnotes

GENTLEMAN JACKSON, shuffled a bit in close quarters at the break, shifted outside foes making steady progress racing four deep into the bend gaining striking distance, continued in that path to challenge nearing midstretch, then took over and went clear under firm handling. STREET CONTENDER, reserved off the pace along the inside early, saved ground to upper stretch and came through close through close quarters to secure second in late stages. TWO BEE, three deep in second flight early, exchanged some contact with STREET CONTENDER, shifted out to challenge three deep leaving the turn, struck the front between calls but failed to sustain his momentum. SON OF TIGER was settled just off the inside early, angled five wide entering upper stretch and found his best stride late to improve his placing. JAKE'S SOLDIER, a bit unruly in the gate, raced in tight quarters along the rail in the opening furlong, exchanged some contact with STREET CONTENDER, was collected off that foe nearing the bend, shifted outside some tiring foes nearing upper stretch to challenge between foes but was outkicked. ATHEIST angled inwards to prompt the pace outside a rival, dueted with that foe into the turn and gave way in upper stretch. SWITCHING TO GLIDE, off a step slowly, never seriously menaced. HANGER THIRTYEIGHT tracked the leaders between foes in second flight, was bumped from both sides after the opening furlong and dropped out early. MASTER SPEAK broke sharply, disputed the pace along inside racing to the bend and gave way in upper stretch.
