Footnotes

TAKE NOTE OF ME was urged to the fore while shifting nearer the inside in the opening furlong, angled to the rail after the opening quarter dictating the pace on a clear margin, turned back a challenger nearing upper stretch then resolutely held the bid of LOST ACCOUNT through the final furlong under strong handling. The latter, urged to gain a contending position along the inside soon after the break, steadied a bit in close quarters after the opening furlong, tracked just off the leaders near the inside into the bend, shifted out to split foes in upper stretch, moved to terms with the winner late but couldn't quite best that foe. CIELO SLEW, steadied out of tight quarters in the opening stages, commenced a steady bid splitting foes racing into the turn, shifted out four wide nearing upper stretch to challenge but was outkicked by the top pair. AFRICA ON MY MIND, allowed to settle along the inside from well out of striking distance, made some belated progress along the inside racing into the stretch. LINDSEYTOHEMAX tracked off the second flight near the inside in the opening stages, made some progress leaving the turn to gain brief contention in upper stretch but had no final kick. HAWK'S GIRL settled off the second flight in the opening stages and never gained contention. HOLY CLASSIC was urged to gain a contending position between foes in the opening stages, steadied a bit off the pacesetter after the opening furlong while crowding LOST ACCOUNT, shifted outside the leader to press that foe racing into the turn but came up empty after five furlongs. BOB'S HILDA broke awkwardly, settled into stride and never menaced thereafter. A J'S DREAM was urged to gain a contending position three deep in the second flight in the opening quarter but was spent after a half. SHOOT THE CROWS shifted outside foes in the

opening stages tracking off the second flight, advanced to make a brief, five wide bid entering the turn but emptied out nearing upper stretch. FOLLOWING THE RACE THE RIDER OF LOST ACCOUNT LODGED A CLAIM OF FOUL AGAINST THE WINNER FOR ALLEGED INTERFERENCE WHICH WAS DISALLOWED.
