FOR THREE-YEAR-OLDS. By subscription of \$300 each horse (Early) April 2, 2003, \$500 each horse (Late Nomination) on June 11, 2003. Fee to accompany the nomination. A Supplementary Nomination of \$7,000 may be made on June 25, 2003, which includes entry and starting fees. Original nominees to pay \$1,250 to pass entry box and \$1,250 additional to start. WEIGHT: 126 lbs. Non-winners of \$100,000 twice at 1 mile or over in 2003, allowed 3 lbs.; \$55,000 twice at 1 mile or over in 2003, 5 lbs.; \$55,000 once at a mile or over in 2003, 7 lbs; \$40,000 at a mile or over anytime, 10 lbs. This event will be limited to 14 starters. ([7] Non-North American starters and [7] North American starters.) Preference given in the following order: (1st)(A) Grade/Group I Turf winners in 2003 - (B) Grade/Group I winners on Dirt; (2nd) (A) Grade/Group II Turf winners in 2003 - (B) Grade/Group II winners on Dirt; (3rd) (A) Grade/Group III Turf winners in 2003 - (B) Grade/Group III winners on Dirt.

LISMORE KNIGHT raced close up along the rail while tracking the leaders, angled out for the stretch run, accelerated in the final furlong and was along in the closing strides. REMIND sprinted to a clear early lead, settled in along the rail with the advantage, turned back a bid from GOOD DAY TOO (IRE) in the stretch then just failed to last in a game effort. GOOD DAY TOO (IRE) raced close up between rivals made a run for the lead in the stretch but could not finish with the top two. SCOTTAGO was void of early speed just outside then finished well with a belated bid that fell short. RAPID PROOF lacked speed and improved his position without threatening. ONTARIO failed to reach a contending position and was not a factor. DISTINGUISHABLE raced close up off the rail and tired in the final eighth. HERCULATED raced near the middle of the field and gave way. LONE STAR DEPUTY saved ground near the middle of the track but tired. EUROPEAN (IRE) proved very difficult to load, broke slowly and trailed throughout.
