### Footnotes

RUN ARNIE RUN broke sharply to gain a clear advantage, dictated the pace on a comfortable margin while a bit off the inside racing into the turn, turned back a challenge from ARTFUL BEE entering upper stretch and held sway to the end under steady left handed prompting. MAWAAQEF, held up out of close quarters at the start, tracked off the second flight while in hand racing to the turn, swung four wide nearing upper stretch to challenge, couldn't gain terms with the winner but prevailed for place honors nearing the wire. ARTFUL BEE was urged to secure striking distance racing just inside the pacesetter in the opening stages, came through close quarters on the turn to bid inside that foe nearing upper stretch but proved no match in late stages while losing second approaching the wire. FRANKLIN COUNTY was settled into stride along the inside in the opening stages, saved ground to upper stretch and gained some position in an even effort. SAINT BREES, bumped by SMOKEM GRAY and forced into the path of CANDY KIN at the start, was quickly collected to chase the pacesetter three wide in the second flight into the bend but steadily faded nearing upper stretch. SMOKEM GRAY hit the gate while breaking outwards bumping SAINT BREES, was righted to chase the pacesetter between foes into the turn but steadily faded after the opening quarter. CANDY KIN, bumped by SAINT BREES and forced out well wide at the start, lost position to the field and never menaced thereafter.
