LESLIE raced near the middle of the field from off the rail, moved up on the final turn, was floated wide into the stretch, took the lead in the lane and drew off under urging. GEANA DAWN stalked the pace from off the rail, drifted out turning for home then gained the place but could not go with the winner late. TURBO ROBO set a fact pace to the stretch from the inside but could not last. LADY DEALER was never a factor. NATASHA PUMPKIN was always outrun. BRIEF BLISS bobbled a few steps out of the gate, saved ground near the middle of the field and tired. THE TRAINER OF TURBO ROBO LODGED A CLAIM OF FOUL AGAINST GEANA DAWN ALLEGING INTERFERENCE IN THE STRETCH BUT IT WAS NOT ALLOWED.
