SILKEN DANDY was urged to the lead from between foes, dictated the pace on a clear margin on his own courage into the far turn and maintained the advantage to the end under firm encouragement, then was vanned off the course following the race after appearing to suffer the effects of heat stroke. SWIFTWATER ROGUE tracked the pace inside a rival in the second flight racing to the backstretch, shifted out to split foes three deep on the far turn and continued with a steady gain to prevail for place honors. CHAS THE MAN, forwardly placed along the inside, tracked the pacesetter to the second bend, continued with a steady bid into the stretch but was outkicked for second. BLAZING FINISH broke awkwardly, settled in last while saving ground to the backstretch, the made some progress in late stages while shifting off the inside in the stretch. RAHY'S PROSPECTOR was urged to secure a forward placing outside the pacesetter, tracked just off the leader to the second bend, made a brief bid between foes nearing upper stretch but flattened out in the drive. FRIENDIAN tracked the pace between foes near the inside and continued evenly into the stretch. THREE RIVERS tracked the leaders outside a rival in the second flight, was caught wide racing through the far turn and faded nearing the stretch. UNCHARTEDTERRITORY, caught four wide racing into the first turn, never gained contention. BITTER TRUTH settled three deep between foes in the last flight early and lacked a rally. MASTERFUL MOVES, reserved along the inside in the opening stages, shifted out to track between foes nearing the second bend, was shuffled back in traffic racing through the far turn and quickly retreated.
