ROTARY was bumped start, never far back off the rail, gained the lead in the stretch and held off opponents in the drive. CHIEF THIEF saved ground, lacked room in the stretch inside, altered course and got up for the place. LIKE AN EAGLE found his best stride late then closed with a rush inside. CAPTAIN BUCKY was bumped at the start, moved to leaders wide in the turn but had no late kick. MAJESTIC ZEAL dueled early but faltered in the lane inside. EIGHTEENTHOFMARCH raced evenly and was eight wide in the stretch. LORD CARMEN was void of early speed and failed to menace. BRAHMS LULLABY was bumped at the start and no factor. DISTORTED GROOM dueled early, was used up and gave way. RACE RUN IN LANE 2.
