Footnotes

ELECTRIC BOAT was settled in hand outside a rival in the last flight in the opening stages, made a steady advance to striking distance while angling four deep leaving the midway point of the turn, continued with a steady response while being fanned six wide racing into upper stretch challenging for command and edged forward to prevail in late stages under firm right handed encouragement. I SEE MAMBO hopped, then was carried inwards at the start, recovered his stride settling off the second flight along the inside, shifted out while advancing on the bend to bid five deep between foes nearing upper stretch, continued to dispute the issue past the furlong marker despite the loss of his rider's whip, but couldn't match terms with the winner late. TRIBUTE TO MOMMA ducked inwards at the start impeding I SEE MAMBO, was righted to gain terms with the first flight racing three deep under rating racing to the bend, moved to challenge between foes in that path racing into upper stretch, dueled for command to late stages but was outfinished by the top pair. COURTESY CALL, in touch from the outset, attended a rival's pace between foes racing to the turn, dueled for command into upper stretch but yielded leaving the sixteenth marker. INNOCENT KITTEN tracked just off the first flight along the inside under rating racing to the turn, came through close quarters to split foes near the inside entering upper stretch to challenge along the rail approaching the furlong marker but lacked the needed final response. GIVERNY GIRL, reserved outside a rival in the second flight in the opening five furlongs, made a brief bid four deep between foes nearing upper stretch but proved empty in the last furlong. TAKE NOTE OF ME moved to the fore along the inside, dictated the pace on a narrow margin racing into the turn but gave way once headed in upper stretch.
