BULLSTAR angled to the inside while racing under reserve tracking just off the leader to the backstretch, came out nearing upper stretch to challenge, then wrested command and drew clear under steady pressure. GONDORF broke outwards brushing NO PASSAGE, was pulling a bit in early stages while securing the lead, dictated the pace on a clear margin into the far turn but proved no match when confronted by the winner. MUSTANG POWDER, reserved three wide between foes in the opening stages, angled to the inside entering the far turn while making steady progress, split foes just off the inside entering upper stretch and continued willingly to earn a share. HISTORIAN tracked the leaders unhurried saving ground in the opening stages and continued in that path while finishing evenly inside foes in the final quarter. NO PASSAGE hopped at the start brushing BRISTOL BOY, was collected to track the pace off the inside, raced four wide into the far turn and had no final response. PATSY'S PROM DATE, caught four wide racing through the first turn while under some reserve, continued five deep on the second bend and never gained contention. BRISTOL BOY, bumped by NO PASSAGE and shuffled back at the start, never menaced thereafter. BURNING CRUSADE tracked the leaders off the inside from just out of striking distance,made a brief, three wide bid between foes and dropped out nearing upper stretch. HENNEPIN COUNTY, urged to secure a forward placing, tracked just off the pacesetter to the far turn but was spent early.
