BUDDHA PASS settled early then made a move while five wide on the turn then ducked in at the top of the stretch and bumped THE ALCOVA KID while impeding others along the inside and behind then held on to cross the wire on top. UNPAID CRUSADE got off slowly and steadied in the first turn and in the first turn then was under a tight hold early before settled off the pace then angled out at the top of the stretch and made a late rally. THE ALCOVA KID was carried four wide into the first turn then made a bid between horses in the stretch but was bumped by BUDDHA PASS and steadied before giving way late. NOLAN'S TERRITORY rated in the middle of the pack then was asked between horses coming off the turn but took up when BUDDHA PASS ducked in then altered course and re-fired too late. GATHERING KINGS set the pace and led to the stretch along the inside but was bumped off stride as part of a multi-bumping incident in the stretch and gave way. CLASS ACK rated in the second flight between horses then rallied to the stretch before being bumped by BUDDHA PASS at the top of the stretch then faded. HONEYMOON HOUSE rated in the middle of the pack then dropped back coming off the turn and made no rally. FOLLOWING A CLAIM OF FOUL BY THE RIDER OF THE ALCOVA KID AGAINST BUDDHA PASS CLAIMING INTERFERENCE IN THE STRETCH, THE STEWARDS TOOK NO ACTION AND THE ORDER OF FINISH REMAINED. RACE RUN ON TURF, 10 FEET INSIDE OF LANE 1.
