REB was allowed to settle and had a rail trip, altered course at the top of the stretch and closed with a rush. NO INFLATION set the pace, was all out in the stretch and dug in gamely the was caught on the wire. OIL MAN (IRE) rated mid-pack then circled the field, lugged in and brushed GIANT OAK then ran on. PROCEED BEE rated in the second flight, made a four wide bid and was bumped hard then ran on late. GIANT OAK showed no speed and steadied early, made a five wide move on the turn then lugged in and bumped PROCEED BEE then gave way. DAKOTA GYPSY rated in the middle of the pack, had a rail trip and lacked room then was never clear. VAQUERO stalked the pace, chased to the stretch then gave way. FOLLOWING A CLAIM OF FOUL BY THE RIDERS OF #3 GIANT OAK and #6 PROCEED BEE ALLEGING INTERFERENCE IN THE STRETCH AGAINST #4 OIL MAN (IRE), OIL MAN WAS DISQUALIFIED FROM THIRD AND PLACED FIFTH.
