### Footnotes

ULTIMATE CLASS gained a position outside a rival in the second flight tracking the pacesetter racing to the turn, made steady progress to advance on that foe nearing upper stretch, took over leaving the furlong marker and held LITTLE NIP safe to the end while shifting out a bit in the closing stages. The latter raced off the second flight nearest the inside racing into the bend, shifted out three deep brushing ISMAEL GRANDE nearing upper stretch, then continued with a steady bid to prove best of the others while being carried out a bit by the winner late. SOMALI BYRD tracked the pacesetter inside a rival in the second flight, continued in hand briefly awaiting an opening racing into upper stretch, then split foes in late stages to prevail for a share. ROYAL POSH tracked the leaders between foes off the second flight racing into the turn, was caught in tight quarters momentarily entering upper stretch but continued willingly to the end to gain some position. FLO'S STRAWBERRY was urged clear while angling to the inside, set the pace on a diminishing margin racing into upper stretch and gave way leaving the furlong marker. HIT GIRL tracked off the second flight outside foes racing three deep into the bend but never gained contention. BROTHERHOOD SINGER shifted widest in early stages and never seriously menaced.
