### Footnotes

MANEKE stalked the pace then made a steady advance on the turn, dug in gamely and held on late. PAPA rated in the middle of the pack and split horses then made a late rally. MITIGATION raced close up and saved ground, split horses then made a late gain. MCMURPHY was allowed to settle, angled out and closed willingly. ROCHESTER CAT chased the pace, contended to the stretch but faltered. CITY NUMBER settled along the inside, angled out but made no rally. ALONE AT LAST was void of speed, moved five wide on the turn and showed some run late. LIGHTHOUSE JUDGE was rushed up and set the pace, led to the stretch then faded. COWBOY SHOES showed no speed, moved seven wide on the turn but made no rally.
