GHORDO lacked speed and was not a factor. MIZZING LARRY raced close up off the rail and weakened. CRABBY APPLETON was outrun. PLEASURABLE set the pace from the inside and tired. SAN SABA pressed the pace from off the rail and gave way. RACE RUN IN LANE 5, RAIL OUT 20 FEET.
