Footnotes

BOLD STREET CAT, reserved outside foes racing in the last flight early, shifted inwards nearing the second bend to save ground while continuing under patient handling, continued in hand awaiting an opening while switching out in upper stretch, then split foes four deep in the last furlong to just edge LET THE LADY SPEAK in time under firm hand urging. The latter was urged to gain a position off the first flight while angling in sharply racing to the first turn, tracked the pace between foes in the second flight to the far turn, advanced to challenge three deep between foes nearing upper stretch, contested the

issue in that path between foes to late stages while gaining the advantage late but just failed to contain the winner. SHINING ON was guided to the inside early while gaining a position just off the first flight, continued inside foes through the far turn awaiting an opening, then altered course in traffic racing into upper stretch while being urged to challenge between foes in close quarters to bid inside the top pair and was just outfinished. SARAH'S SPLENDOR, held up between foes off the second flight racing to the backstretch, made steady progress to gain contention while being fanned five wide entering upper stretch and was just outkicked. KING'S FAVOR broke slowly, steadily gained position between foes just off the inside racing into the far turn, shifted out to bid four deep between rivals entering upper stretch but lacked the needed final kick while ducking inwards in the final sixteenth. WAPANUCKA, urged to terms with a rival on the pace racing into the first turn attending the tempo, pressed the issue between foes on the far turn to upper stretch but gave way late. CAUSEMOMMASAIDSO, reserved along the inside tracking off the second flight in the opening half, came through some close quarters near the inside racing into upper stretch to gain some position but had no final kick. GENEVA LAKE drifted a bit early while being prompted to gain a contending position tracking just off the first flight, was urged to advance while drifting out markedly racing through the far turn and gave way racing into the lane. A UNIQUE LADY, caught in tight quarters between foes just after the start, was shuffled back early and never menaced thereafter. HEART TO ME was urged to the lead along the inside from the break, dueled for command into the far turn and gave way abruptly after six furlongs. SPIRIT OF A NATION, caught in tight quarters between foes just after the break, was caught four wide racing into the backstretch while being prompted to contend but retreated early.
