**Footnotes**

CAPT. BULLET BOB moved to the fore soon after the break to gain a narrow advantage, dictated the pace in hand a bit off the inside racing into the turn, then was roused in upper stretch to extend his advantage to the wire. ALARMING AFLEET broke sharply, stalked the pacesetter under reserve racing well off the inside in the opening half, angled inwards nearing the bend to lead the second flight racing three deep through the bend, couldn't gain terms when urged to challenge in upper stretch but held a rival for place honors. THANKFULNESS, held up just off the leaders in early stages, angled to the rail approaching the turn, came through inside a rival to challenge entering upper stretch and finished evenly in late stages. RICH CITY DUDE, reserved four wide off the second flight in the opening half, continued in that path entering the turn while being urged to contention and finished evenly through the stretch. LEMON CUSTARD, unhurried early racing behind the second flight along the inside, saved ground to upper stretch but had no closing bid. TUCKY tracked the leaders unhurried off the second flight while outside foes racing to the turn but never mounted a serious challenge. DUKE OF DEL REY, reserved while angling inwards nearer the inside in the opening stages, trailed throughout.
