E T PHONE LAURA raced close up just outside, rallied to the lead on the turn and drew off while drifting out from a left handed whip. SINGSINGASONG lacked speed off the rail and rallied for the place but could not reach the winner. WINGS TRUE saved ground near the middle of the field and rallied along the rail but flattened out in the drive. LADY DEALER raced off the rail and never reached a contending position. SAMMYBDANCING lacked speed and improved her position. ROBYN'S PROOF was also void of speed and also improved her position without threatening. RUBY RED SLIPPERS made a bid in the stretch but faltered late. BRIDGE EDITION set the pace from the inside and tired. ALOHA CAROL was through early. THE RIDER ABOARD SINGSINGASONG LODGED A CLAIM OF FOUL AGAINST E T PHONE LAURA ALLEGING INTERFERENCE IN THE STRETCH BUT IT WAS NOT ALLOWED.
