### Footnotes

HELICOPTER, reserved outside foes racing just out of striking distance in the opening stages, was fanned five wide entering the backstretch, continued with a steady advance on the leaders while shifting out four wide leaving the midway point of the far turn, wrested a narrow advantage nearing midstretch, then shifted out under left handed urging in the last furlong to just hold the challenge of BOBBY SANDS while bumping that foe several times. The latter, reserved three deep between foes in the opening half, continued unhurried outside foes entering the far turn, angled five wide nearing upper stretch while moving into striking distance, drew on terms with the winner leaving midstretch, then was bumped and carried out in the last furlong while failing to gain even terms with that rival. UNBRIDLED VICAR, reserved near the inside in early stages, shifted out nearing the backstretch, continued between foes to the second bend, then angled out five wide entering upper stretch while making an effort to improve position. COURTESY TITLE moved to the fore along the inside racing to the backstretch, continued to attend a rival's pace racing through the backstretch, dueled for command entering the far turn and gave way leaving midstretch. RIVER OF NO RETURN, allowed to settle in last for five furlongs, saved ground to upper stretch and passed inside tiring rivals. GRAY, forwardly placed along the inside tracking just off the first flight racing to the far turn, came up empty entering upper stretch. SHIP'S CABIN, forwardly placed outside a rival in the opening stages, went up to prompt a rival on the pace racing into the far turn and gave way abruptly entering upper stretch. FOLLOWING THE RACE THE RIDER OF BOBBY SANDS LODGED A CLAIM OF FOUL AGAINST THE WINNER, ALLEGING INTERFERENCE AND THE STEWARDS ALSO CONDUCTED AN INQUIRY INTO THE STRETCH RUN BUT ELECTED TO TAKE NO ACTION.
