BARBIES M, reserved along the inside racing into the first turn, shifted outside foes entering the backstretch, made steady progress to gain a position four deep off the first flight on the far turn, angled out five wide in upper stretch while moving to challenge, was forced out into the seven path nearing the sixteenth marker but responded to firm handling to narrowly prevail in time. RICHYSTHUNDERINGAL moved to gain a position just off the pacesetter, was firmly rated stalking that foe racing into the backstretch, steadily increased the tempo to challenge nearing upper stretch, gained the advantage leaving the furlong marker, swerved out sharply nearing the sixteenth marker impeding DELUXE HEIR and forcing out the eventual winner but continued with interest to prevail for second on the wire. FLEET CLASSIC moved to the fore while angling to the inside racing to the first turn, dictated the pace on a narrow margin under light rating to the second bend, resisted grudgingly when challenged racing into upper stretch but was just outkicked. RAVE REVIEWS gained a position outside a rival in the second flight while under reserve in the opening half, made steady progress on the far turn to bid three deep nearing upper stretch, contested the issue between foes past the furlong marker but was outfinished. DELUXE HEIR tracked off the second flight outside foes racing to the backstretch, made a steady advance to contention four deep on the second bend, moved to challenge in that path between foes in upper stretch, was carried out by RICKYSTHUNDERINGAL nearing the sixteenth marker while being forced into the path of the eventual winner and checking her stride, then

failed to regain her momentum. OUR DELIGHT broke outwards bumping LADY OF RIVENDELL, was collected to track between foes off the second flight racing to the far turn, made some progress splitting rivals racing into upper stretch but finished evenly in late stages. LAWFUL LADY angled inwards racing to the first turn to split foes, steadily drew into a position in the second flight after a half, made some progress to gain striking distance along the inside on the second bend but weakened racing along the rail in late stages. LADY OF RIVENDELL, bumped at the start, was settled off the second flight racing along the rail to the far turn, was shuffled in traffic midway through the second bend, shifted off the inside nearing upper stretch but offered no rally. FUDGELUV, reserved outside foes in the last flight racing to the backstretch, never mounted a serious challenge. SHO BIZ SREVA settled in the last flight along the inside in the opening half and never mounted a serious challenge. TART'S KNICKERS moved to a forward placing while angling to the inside tracking the leaders as part of the second flight in the opening half but steadily retreated from contention on the far turn. FOLLOWING THE RACE THE TRAINER OF DELUXE HEIR LODGED A CLAIM OF FOUL AGAINST THE RIDER OF RICHYSTHUNDERINGAL AND THE STEWARDS ALSO CONDUCTED A CONCURRENT INQUIRY INTO THE INCIDENT IN THE STRETCH. AFTER A REVIEW, THE STEWARDS DISQUALIFIED RICHYSTHUNDERINGAL FOR INTERFERENCE, PLACING HER FIFTH.
