ENGLISH COUNCIL gained terms with a rival attending that foe's pace under light rating racing into the backstretch, lost some ground to the leader while shifting inwards a bit racing into upper stretch but continued with a steady late response under firm encouragement to wrest command in time. TAP THE DREAM tracked just off the first flight outside a rival in the opening half, shifted out three deep racing into upper stretch while being roused to challenge and continued with interest to prevail for the place honors while failing to match the winner's kick. APOLLYON broke readily, moved to the fore along the rail, dictated the pace on a narrow margin into the far turn, was roused to extend the advantage into upper stretch but failed to sustain that momentum. MYLES tracked the leaders inside a rival in the second flight, saved ground to upper stretch while racing momentarily in close quarters entering the lane but lacked the needed final response. JACK N JOHN worked way to the inside tracking well off the second flight and continued evenly to late stages. BURNT TREE settled along the inside racing to the backstretch and never gained contention. TURBALO passed only tiring rivals. LIGHTHOUSE PRIDE never seriously menaced. CURZON STREET tracked off the second flight well off the inside racing to the backstretch and dropped out early. FOLLOWING THE RACE THE RIDER OF MYLES LODGED A CLAIM OF FOUL AGAINST THE WINNER WHICH WAS DISALLOWED.
