FOR THREE YEAR OLDS. Nominations close Wednesday, August 1, 2007 with no fee. A supplementary nomination may be made at time of entry for \$500 which includes entry and starting fees. \$150 to enter and \$150 additional to start with \$45,000 added of which 60% of all monies to the owner of the winner, 20% to second, 11% to third, 6% to fourth and 3% to fifth. Weight; 121 lbs. Winners of \$50,000 in 2007 2 lbs. extra. Non-winners of \$35,000 once or three races other than maiden or claiming allowed 2 lbs. Of \$30,000 once in 2007 or two races other than maiden or claiming, 4 lbs. Of \$24,000 in 2007 or \$18,000 twice, 6 lbs. (Maiden, claiming and starter races not considered.) The field will be limited to 12 starters. Highweights preferred. Lifetime earnings will be used to determine the order of preference of horses assigned equal weights. Two horses having common ties through ownership cannot start to the exclusion of a single interest. Nominations Closed Wednesday, August 1, 2007 with 27.

LOVANGO raced in the second flight while inside, was well rated through the turn, angled out at the top of the stretch and drew away. MORADA KEY broke inward and was bumped, was allowed to settle and closed late while seven wide. FRONT COURT rated in the middle of the pack, made a five wide move in the turn and was gaining late. MAN ABOVE was rushed to contention and grabbed the lead into the far turn, led into the stretch and faded late. WHO LET THE CAT IN settled along the inside, moved up into the turn and flattened out. HAPPY HUMOR broke sharply and set a pressured pace then tired in the stretch. PIRATE SAINT rated in the middle of the pack, was asked between horses in the turn but made no rally. GALLOPING HOME dropped back early and showed no speed and was no threat. SNOWBLIND FRIEND was shuffled back at the start and was void of early speed, altered course in the stretch but closed no ground late. SHIPMATE was bumped at the start and raced close up early then stopped after a half.
