TOP PAIR, reserved off the second flight along the inside in the opening half, shifted out on the far turn while steadily drawing into striking distance, split foes four wide racing through the stretch, wrested command nearing the sixteenth marker and forged clear under strong handling. AVANTIBDANCING, bumped at the start, was urged to the lead while angling to the inside, dictated the pace on a comfortable margin to the second bend, was roused to hold sway past midstretch but proved no match when confronted by the winner. ZORI'S EYE, reserved outside a rival in the second flight racing to the backstretch, shifted out entering the second bend commencing a steady, three wide bid between foes but faded nearing midstretch when failing to match the top pair but continuing well enough to prevail for a share. LUCKY GAL settled off the second flight racing to the backstretch, angled out four wide entering the far turn while making some progress to gain striking distance but steadily faded in the last quarter. ARRESTED BY DUFFY broke outwards bumping AVANTIBDANCING, was steadied a bit, settled into stride along the inside for six furlongs, shifted out in upper stretch and made an effort to improve position between foes in the last furlong. MEMORY HARBOR, reserved outside foes racing to the backstretch, never mounted a serious bid. MILESTONEMISSILE angled inwards racing to the first turn to stalk just off the pacesetter under rating, made a brief bid between foes racing through the far turn but came up empty entering upper stretch. ROCHELLE ROCHELLE, reserved along the inside racing behind the second flight in the opening stages, shifted out racing into the far turn and soon dropped out of contention. HURRACANE KATIE tracked the leaders under light rating along the inside as part of

the second flight in the opening half but steadily retreated racing through the far turn.
