Footnotes

TWO NINETY FIVE, bumped at the start, was quickly righted to track the leaders along the inside as part of the second flight, steadily gathered momentum leaving the second bend while switching out four deep, wrested command leaving the furlong marker and held AL NASR DREAM (IRE) safe under firm

handling. The latter, reserved three wide between foes behind the second flight in the opening half, made steady progress outside foes to gain striking distance leaving the far turn, angled five wide in upper stretch and closed the gap on the winner late. SWITCHING TO GLIDE shifted out bumping TWO NINETY FIVE at the start, went to the lead dictating the pace to the backstretch, shifted outside a rival to regain command entering upper stretch but weakened when failing to fend off the top pair late. MY EX tracked the leaders three wide in second flight, angled inwards entering the second bend while making some progress but had no final response. FOUR TO GO, reserved well off the leaders to the backstretch, was fanned six wide racing into upper stretch and made some belated progress. JACKS AGAIN was settled saving ground to the backstretch, shifted out to split foes entering upper stretch and made some mild progress. HEZA FLAMER, caught four wide in the opening stages tracking off the second flight, continued outside foes to the second bend but couldn't produce the needed closing bid. ALABAMA GOLD tracked just off the leaders between foes in second flight, advanced in tandem with the eventual winner while just outside that foe leaving the far turn but gave way in upper stretch. COMELATELEAVEEARLY was settled between foes in the opening stages and offered no rally. UNO PECADOR angled outside foes to race four wide on the first turn, commenced a sharp move nearing the backstretch, pulled his way clear after a half, dueled inside a rival on the second bend and emptied out in the drive. BUDDY'S BID, bumped at the start, tracked the leaders between foes near the inside in second flight but dropped out early. MR. SEABRA angled inwards to join the pace outside a rival racing to the backstretch but was spent after a half.
