### Footnotes

EXTRAORDINARY CAT showed quickly in front, shifted to the inside dictating the pace in hand racing into the bend, widened his margin racing into upper stretch when given his cue and was kept to steady right handed encouragement. DOCKTOR DEMENTED, urged to contend between foes in the second flight racing into the turn, shifted out in upper stretch and continued well enough to edge a rival for place honors. RUNNINGOUT OF CASH broke slowly, then was bumped by SERRATED EDGE, was urged to gain a position three deep in the second flight in the opening quarter, loomed briefly outside the pacesetter in that path entering upper stretch but lacked the needed final kick. HESTON shifted out early while taking up a position behind the second flight, shifted out four wide racing into upper stretch and made an effort to improve position. MESA RICA settled off the second flight in the opening stages while making his way nearer to the inside, continued between foes while shifting out racing into upper stretch but lacked the needed late response. STABLE CURRENCY was urged to contend inside foes in the second flight while shifting a bit off the rail pursuing the winner racing into the turn but emptied out abruptly entering upper stretch. STAGE TAPPER settled off the second flight in the opening stages and never gained contention. SERRATED EDGE broke inwards bumping RUNNINGOUT OF CASH, was settled outside foes early, shifted to the inside on the turn while briefly gaining position racing into upper stretch, was pulled up after taking an awkward step leaving the three sixteenths marker, then was vanned off the course.
