**Footnotes**

UNO PECADOR tracked the leaders from just out of striking distance racing off the second flight to the bend, made steady progress on the turn while caught five wide advancing to contention, moved to challenge four deep entering upper stretch and continued with a steady late response to narrowly prevail in time under firm encouragement. HUCKLEBERRY BOY tracked the leaders unhurried along the rail from just out of striking distance racing to the turn, saved ground to upper stretch while making steady progress to challenge inside the leaders and was just outkicked. MAMBO DANCER dueled for command along the inside racing into the turn, shook clear entering upper stretch, shifted out under pressure near the sixteenth marker and just failed to sustain his momentum. TWYLAS RED CAT joined the pace between foes soon after the start, dueled for command into upper stretch, lost some position to the leader but continued willingly between foes to just miss for a share. WAKEUPBRANDON joined the pace four wide in the opening furlong, pressed the issue three deep racing into upper stretch and gave way leaving the furlong marker. GRATAN STREET settled out of striking distance in early stages while angling nearer to the inside, shifted out in upper stretch and made some belated progress between foes. SORROWFUL JONES flashed brief pace three deep between foes in the opening stages but retreated from contention early. CALL TO GLORY was never a factor. MANO POINT trailed the field to the stretch. SWITCHING TO GLIDE, close up between foes in the opening furlong, was eased out of tight quarters to track just off the first flight racing into the turn but steadily faded nearing upper stretch.
