Footnotes

DEVILS TOWER was rated off the second flight a bit off the inside in the opening quarter, commenced a steady advance on the turn while shifting outside foes, angled four wide nearing upper stretch and continued with a solid closing response to wrest command and kick clear under firm encouragement. DADDYSPENTDAMONEY was reserved outside a rival in the last flight racing to the turn, made steady progress to gain contention while being fanned five wide racing just off the eventual winner entering upper stretch, couldn't match that foe late but continued with interest to edge a rival for place honors on the wire. ESPRESSO, reserved in the last flight along the inside, saved ground to upper stretch and was making steady late progress inside foes to just miss for the place honors while prevailing for a share. MR. MOSTLY was urged to dispute the pace inside rivals from the outset, dictated terms on clear margin racing into upper stretch but failed to sustain that momentum. DINA BOY tracked the leaders along the inside as part of the second flight, advanced along the rail on the turn to lodge a brief bid inside foes racing into upper stretch but lacked the needed final kick. OH MY TODD, within striking distance three deep stalking just off the first flight racing to the turn, was urged to advance in that path nearing upper stretch but came up empty approaching the furlong marker. REPHRASE was rated off the first flight tracking the pace between foes, was caught in some close quarters while racing three deep between foes nearing upper stretch, switched out entering the lane but had no closing response. DUSTINCASE, in touch with the pacesetter in the opening stages prompting that foe's pace, retreated from contention early.
