HEATHER'S ROSE, in touch with the leaders just after the start, was eased off the leaders to track the pace between foes, shifted to the inside nearing the turn while making a steady advance to contention, briefly awaited an opening nearing upper stretch, was roused between foes just off the inside while making contact with DEEVEEARE and OUR BARRY GIRL nearing midstretch to challenge for command inside SHES A BULLSEYE in late stages but wrested command from that foe in time under steady handling. The latter tracked the leaders outside a rival in the second flight early, steadily moved to striking distance while being fanned four wide racing into upper stretch, gained the advantage leaving the furlong marker but couldn't fend off the winner's bid. LET'S TRY ANOTHER settled last along the inside dropping well off the field early, steadily gathered momentum along the rail on the turn, staided out of close quarters nearing upper stretch, then altered course to race five wide in the stretch, continuing with interest to gain some position. OUR BARRY GIRL was hustled between foes from the break to dispute the pace inside a rival in the opening stages, conceded the lead to that foe to track just off that foe winner near midstretch and soon gave way. DEEVEEARE was urged to join the pace outside a rival soon after the break, dued for command into upper stretch, exchanged some contact with the eventual winner leaving midstretch and quickly gave way. UNO ONE settled between foes off the second flight racing into the bend and never gained contention. DEFIANT SUSIE angled inwards early to track just off the first flight, shifted out racing into the bend to lodge a brief bid three deep between foes but quickly came up empty. KATHLEENS IMAGE tracked off the second flight outside foes in the opening stages but dropped out of contention early. CHICAGO RUHLS tracked off the second flight along the inside racing to the turn and steadily faded nearing upper stretch.
