SOAPSTONE PRAIRIE raced three deep into the first turn taking up a position just off the first flight in the opening half, steadily moved to challenge the pacesetter entering the second bend, gained the advantage racing into upper stretch and responded to firm handling to maintain the advantage to the end under right handed pressure. FRIENDIAN was settled in last near the inside racing to the backstretch, switched outside foes nearing the far turn commencing a steady advance, angled four wide racing into upper stretch and found his best stride late to close the gap while edging a rival for second. UNCHARTEDTERRITORY tracked just off the first flight along the inside under light rating in the opening stages, came around some tiring foes to challenge along the inside racing into upper stretch and continued willingly between foes in the closing stages while steadily gaining to the end. DUKE OF RUTHERFORD, forwardly placed outside a rival attending the pace racing to the first turn, took over from that foe on the backstretch to dictate terms into the second bend, disputed the issue inside the winner racing into upper stretch but failed to sustain his momentum. PIECEOFTHEACTION broke readily to gain the advantage, set the pace on a narrow margin along the inside, couldn't match the leaders after being headed midway through the backstretch and gave way on the far turn. HEAD OF STATE settled outside foes off the second flight racing to the backstretch and never mounted a serious challenge. BARANIT tracked off the second flight along the inside in the opening stages but never seriously menaced.
