Footnotes

CELESTIAL CITIZEN, urged to dispute the pace along the rail racing into the turn, shook clear nearing midstretch and held sway on a clear margin to the end under brisk handling. ZIPPED AGAIN broke slowly, made a steady advance to regain contention along the rail racing into the turn, then continued inside foes to the stretch to prove best of the others. GRAND SYMPHONY broke outwards bumping BALLYGAWLEY, was settled in last racing to the turn, swung out seven wide entering upper stretch and produced her best stride late to prevail for a share. BALLYGAWLEY, bumped at the start, was collected, then urged between foes five deep to gain a position just off the first flight, moved to challenge three deep nearing upper stretch and was just outkicked for a share. MISTYMOON LAKE, urged to a contending position three deep between foes early, tracked off the first flight between foes racing into the bend and continued evenly into the stretch. CUPID'S BEST, urged to force the pace outside a rival racing into the turn, pressed that foe to upper stretch and gave way. SPECTACULR SPARKLE settled into stride off the inside, split foes racing into the stretch gaining some position but made no real impression. BONEAFIDE CAT tracked off the second flight three deep racing into the bend and never gained contention. PRETTY PERCEPTIVE, urged to contention

six wide in the opening quarter, soon retreated from contention. JEANSTHATFIT flashed brief pace four wide between foes racing into the turn but dropped out of striking distance early.
