ALL TANKED UP rated early, ran down the leader five wide and got up in the finals strides. BAMBINI set a pressured pace, was getting out a bit in the long drive and just missed. STRUT 'N STROLL wouldn't load in the gate, was blocked in the lane then altered course and rallied when clear. DAKOTA SMOKE stalked the pace inside but failed to sustain the bid. DERELICTE was slow early, forced wide in the stretch and made a late gain. RUN WITH EAGLES

stumbled badly at the start, veered out sharply in the stretch and had no rally. TWYLAS RED CAT had a wide trip and was forced out in the stretch. GRAND BAILOUT raced mid pack and lacked a late response. RACETRACK JACK wouldn't load in the gate, had early speed and gave way. READY TO ROMP had good early speed and flattened out. RUN OR PASS was through early and forced wide in the stretch. ZIPPY MY BOY broke slowly and always outrun. RACE RUN IN LANE 3, 6 FEET OUT. THERE WAS A JOCKEY'S CLAIM OF FOUL FOR INTERFERENCE IN THE STRETCH BUT NO ACTION WAS TAKEN.
