Footnotes

THUNDERING CHANCE tracked the leaders three wide in second flight in the opening stages, made a steady advance in that path to join the pacesetter nearing midstretch, wrested command from that foe and drove clear. MARIA DARLIN forced the pace four deep from the outset, dueled outside a rival into upper stretch, struck the front near midstretch but proved no match when confronted by the winner. MILESTONEMISSILE tracked off the second flight while angling inwards a bit, angled four wide leaving the midway point of the turn while making solid progress and continued willingly in that path to earn a share. ANOTHEROTHERWOMAN tracked the pace in second flight between foes, shifted to the inside on the bend, made progress inside foes to gain striking distance entering upper stretch but was outkicked. TRAVIS'S PRINCESS was urged to contend while angling to the inside in the opening stages, stalked just off the leaders on the turn, shifted out entering upper stretch but lacked the needed final response. SHE'S ABOVE DA LAW was eased off the pace racing along the rail soon after the break, shifted out to race five wide entering upper stretch and made some mild progress. CROWN THE CAT settled along the inside off the second flight early, saved ground to upper stretch but lacked the needed rally. MY SWEET REVENGE briefly disputed the pace between foes but emptied out midway through the bend. PRINCESS FREEDOM was urged to the lead racing three wide between foes from the break, dueled for command inside a rival on the turn and gave way in upper stretch. SWEDISH BEAUTY stumbled badly at the start and trailed throughout.
