### Footnotes

COWGIRL JUSTICE came through close quarters leaving the gap to track the leader behind the second flight while angling to the inside, continued with a steady response while shifting out three deep nearing upper stretch and produced a sustained rally to just edge CASE CRACKER on the wire under firm handling. The latter was urged to the lead while angling to the rail, dictated the pace on a narrow margin racing into the bend, turned back a rival to regain a clear advantage in upper stretch but just failed to contain the winner. MASQUERADE FASHION tracked off the second flight outside foes early, angled to the rail racing through the turn and continued with an effort to improve position inside foes while prevailing for a share. LIL MISS RICHIE, came through close quarters leaving the gap while being urged to secure a contending position, switched outside the leader racing into the turn while prompting that foe into upper stretch but gave way nearing the furlong marker. TAKE WHAT YOU CAN tracked the pacesetter between foes in the second flight early but steadily faded racing into upper stretch. DE LICA was never a factor. MORIOBA, held up avoiding close quarters just after the start, never menaced thereafter.
