JOSE ADAN was unhurried early, took the lead mid stretch, veered over sharply, interfered with TERRAIN and lasted. ADVICE had no speed, moved to the leader in the stretch, lugged out late and interfered with TERRAIN. TERRAIN made a steady advance, made a bid in the stretch, was taken up while impeded with in the lane both in the early part of the stretch and in the latter part of the run.. ZION was unhurried early, had no room in the stretch, altered course inside and was gaining. MY DOMINICK JAMES stalked the pace but failed to sustain the bid and weakened between horses late. CAPT. CANDYMAN CAN raced close up on the backstretch, made a bid in the stretch, but was taken up while in tight quarters. HIS GREATNESS swung out widest in the turn then had a mild rally. READY RACER was slow early, saved ground and improved position. SCHLEPROCK was void of early speed and outrun. INVESTOR was through early and no factor. MALIBU MAVERICK set the pace, drew off early, was used up and stopped. MY MAN MORAN had good early speed then flattened out. AFTER MULTIPLE INQUIRIES AND JOCKEY'S OBJECTIONS BOTH JOSE ADAN AND ADVICE WERE DISQUALIFIED FOR INTERFERENCE IN THE STRETCH.
